Testamentary Bequests

A testamentary bequest allows you to shape the future of Montfort, helping us serve a growing and aging population.

You can designate a specific amount or opt for a **residual bequest**, which allocates the remaining portion of your estate after all debts and specific bequests are settled.

A **contingent bequest** allows you to choose Montfort as the beneficiary if your primary heirs are unable to inherit, ensuring your support for future generations.

This flexibility ensures that your wishes will be fulfilled, while supporting Montfort in its mission.



MEANINGFUL WAYS To leave a legacy

Life Insurance

This approach allows you to give a significant gift without impacting your immediate assets.

Designating Montfort Foundation as the **owner and beneficiary** of a life insurance policy enables you to support our goals of expanding services and enhancing healthcare access for underserved populations. In doing so, you will receive a charitable income tax receipt corresponding to the total amount of premiums paid during the year

Naming the Montfort Foundation as the **beneficiary** of your life insurance policy ensures the death benefit goes to the Foundation upon your passing. For this option, premiums are not tax-deductible, but it reduces the taxes your estate will owe.

Endowment Fund

By creating an endowment fund, you ensure that your legacy will support the future of Hôpital Montfort.

The capital is preserved in perpetuity, with the income used to support ongoing efforts to serve an aging population, enhance research as well as educational initiatives, and innovate care delivery.

This fund could be named in your honor or dedicated to a loved one, continuing your support of Montfort's mission for generations to come.

Gift of Securities

A gift of securities allows you to contribute through investments in stocks, bonds, or mutual funds, offering significant tax advantages while supporting Montfort's long-term goals.

This is an ideal option for those wishing to avoid capital gains taxes, while making a substantial impact on our ability to expand services, enhance social accountability, and innovate in education and research.
